Troubling Times Require Greater CWCF Help

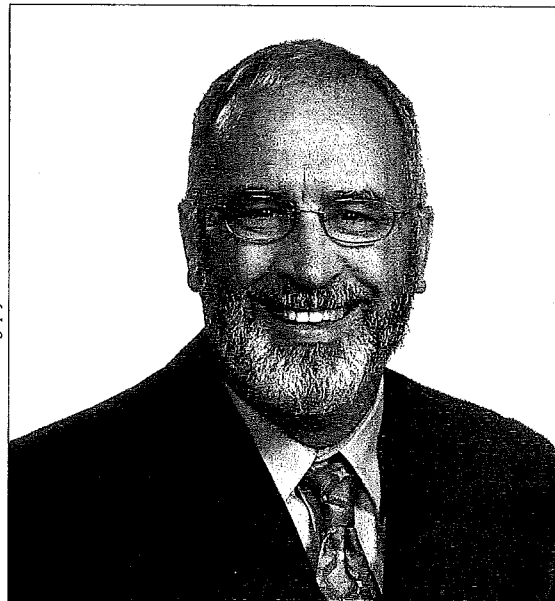
In these very tumultuous economic times, the *Central Washington Catholic Foundation* (CWCF) gave away \$96,050.49 in grants and scholarships to worthy Catholic causes last quarter – the highest single payout ever in the Catholic Foundation’s short history.

This quarter, for the first time ever, the Board of Trustees chose to sponsor three grant proposals beyond named fund recipients. These grants went to worthy Catholic causes in our greater community.

Catholic Charities Housing Services received \$1,500 for a computer lab for Casa Guadalupe in Chelan County. **Reach Youth Ministry** in Cowiche received \$1,500 for staff laptop computers. In Ellensburg, **St. Andrew’s Catholic Church** received \$475 for record-keeping software for their parish and Religious Education programs.

The deadline for the next round of grant proposals is **January 15, 2009**.

En estos tiempo de grandes perturbaciones económicas la Fundación Católica de Washington Central, durante el último trimestre entregó \$ 96.050.49 en donaciones y becas a causas católicas de gran trascendencia. – el mayor desembolso hecho por la Fundación Católica en su corta historia.

Este trimestre, por primera vez, la Mesa Directiva tomó la decisión de apoyar tres peticiones específicas hechas por personas que no son nuestros beneficiarios ordinarios. Estas donaciones específicas tuvieron como destinatarios causas Católicas de primera importancia en nuestra Comunidad de Washington Central.

El Programa de Vivienda de las Caridades

Católicas recibió \$ 1.500 para un laboratorio de computadores en la Casa Guadalupe en el Condado de Chelan. El Ministerio Juvenil Reach en Cowiche recibió \$ 1.500 para computadores portátiles para el personal. En Ellensburg la Iglesia Católica de San Andrés recibió \$ 475 para un software para los archivos de los programas parroquiales y para el Programa de Educación Religiosa.
