CWCF Gives Away Over \$35,000 To Area Catholic Works, Two Scholarships

The *Central Washington Catholic Foundation* (CWCF) gave out \$35,847.13 this fall to 10 Catholic works and two scholarships. This money was part of 19 Named Fund payouts. Named Funds are specific funds setup by donors to benefit Catholic entities in Central Washington. The CWCF has 30 Named Funds.

Dylan T. Sattler received \$3,051.46 for the Mary Ellen Chott-Mahre Scholarship. Dylan is attending Gonzaga University. Leticia Navarro received the John Rodriguez-Kranz Scholarship for \$500.00 and is attending Yakima Valley Community College.

The Catholic works to receive fall money are: Blessed Sacrament Parish, in Grandview \$3,352.62;

Catholic Family & Child Services, in Yakima \$961.70; Christ the King School, in Richland \$4,748.41; the Diocese

of Yakima Seminarian Education \$7,706.94; Holy Family Parish, in Yakima \$6,881.67; St. Joseph's School, in Wenatchee \$2,416.47; St. Joseph/Marquette School, in Yakima \$961.70; St. Paul Cathedral Parish, in Yakima \$596.10; St. Paul Cathedral School, in Yakima \$3,866.25; and St. Rose of Lima School, in Ephrata \$803.81.

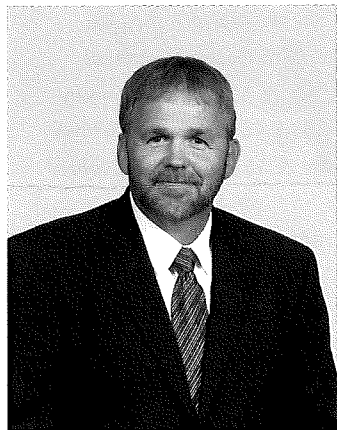

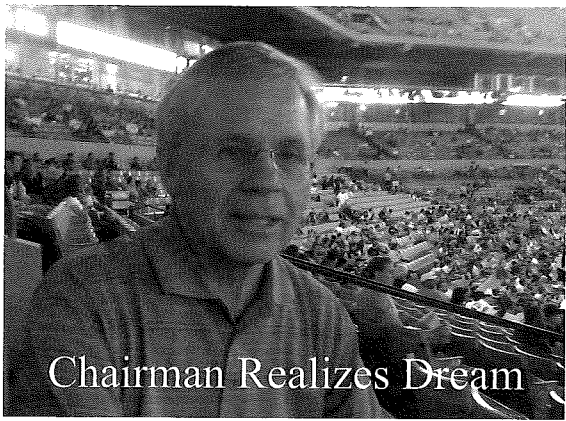
