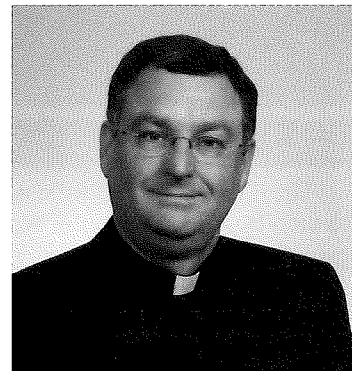
Foundation Searches for New Executive Director; Fr. Bellino Accepts Position in California

YAKIMA, WA – Rev. Samuel P. Bellino, S.J., Executive Director of *Central Washington Catholic Foundation* (CWCF) announces his intentions to leave his position. A national search for a new director is presently underway.

Father Bellino has been CWCF's executive director since 2002. He is a California Jesuit priest and plans to return to his province. Fr. Bellino is a member of the Yakima Downtown Rotary and volunteers as a vice president for the Executive Board of the Grand Columbia Council of the Boys Scouts of America.

As one of the four founding members of CWCF, Fr. Bellino has helped the foundation raise over \$5 million dollars since its inception in the fall of 2002.

In addition, during his tenure, Fr. Bellino is credited with helping create the Francis Eugene Cardinal George Medallion Award. Given out once every three years, it encourages public recognition of members of the Catholic Community in Central Washington whose lives and accomplishments reflect the mission and values of CWCF.



CWCF Awards \$10,000.00 In Fall Grants to Area Catholics

The *Central Washington Catholic Foundation* (CWCF) funds 11 fall grant proposals for a total of \$10,000.00. This funding assists Catholic schools, parishes, agencies and fraternal groups in Benton, Chelan, Douglas, Grant, Kittitas, Klickitat and Yakima counties. New grant proposals are due January 15, 2011.

Saint Paul Cathedral School in Yakima received \$750.00 for TV/DVD units. St. Rose of Lima Catholic School in Ephrata was awarded two grants totalling \$1,500.00 for Physical Ed and Sports Field equipment. Saint Joseph Catholic School in Kennewick was granted \$750.00 for laptops for students.

In Kennewick, Saint Joseph Catholic Church received \$750.00 for the youth band music system, bibles and catechism materials.

The RCIA program at Saint Paul Cathedral Parish was granted \$750.00 for a laptop, projector, cart and software.

The Diocesan Committee on the Catechumenate was awarded \$1,500.00 for a priest and deacon workshop.

Catholic Family and Child Service found funding for four grant proposals. The Strengthening Families Program in the Lower Valley received \$1,500.00, which was more than they had asked. Carroll Children's Center of Yakima was awarded \$1,000.00 for a "baby fence." Chelan-Douglas counties' Volunteer Chore Services found funding for wheelchair batteries, waste management and VSC mileage. Yakima's Respite Adult Day Center received \$750.00 for meals.

El Padre Bellino ha sido el director ejecutivo de la CWCF desde 2002. Él es un sacerdote jesuita de California y planea volver a su provincia. El Padre Bellino es un miembro del Club Rotario del centro de la

cuidad de Yakima y se ofrece como voluntario sirviendo como vicepresidente para la Mesa Directiva del Gran Consejo de Colombia de los Muchachos Exploradores de América.

Como uno de los cuatro miembros fundadores de la CWCF, el Padre Bellino ha ayudado a la fundación a reunir más de 5 millones de dólares desde su inicio en el otoño de 2002.

Además, durante su cargo, el Padre Bellino es acreditado con ayudar a crear el Premio Medallón Cardenal Francis Eugene George. Presentado una vez cada tres años, este anima el reconocimiento público de miembros de la comunidad católica en Washington central cuyas vidas y logros reflejan la misión y valores de la CWCF.
